NORMS AND RULES TO BE OBSERVED BY VISITORS TO TH ESTATE FOREST RECREATIONAL AREAS

- 1. Users must arrive at the area between 12:00pm to 5:00pm and shall hand the authorized permit to the Forest Management Officer.
- 2. Motor vehicles must be parked in the designated areas or in the areas indicated by the Forest Management Officer.
- 3. Using other recreational areas of the forest is not allowed without an official visitor's permit. There is an addictional charge of \$1.00 for each visitor over 10 years of age.
- 4. Writing, painting, marking, scratching, mutilating, damaging or destroying any structure, facility, or property in the forest areas is prohibited.
- 5. Cutting, killing, destroying, mutilating, removing, burning, painting, poisoning or in any other way damaging any tree or plant within the forest is prohibited.
- 6. Altering, removing or damaging the signals or signs installed by the Department of Natural and Environmental Resources or by any authorized government agency is phibited.
- 7. Affixing, painting, attaching, carving, or putting up posters, signs, advertisements, notices, or leaflets along roads, paths, or trails, on trees, plants in general fenses, or facilities within the recreational areas, except for those previously authorized by the Department of Natural Resources temporarily for special permitted activities, is prohibited.
- 8. Removing or moving tables, benches, or other equipment from the place where they are set up or located is prohibited.
- 9. Lighting fires in places other than those provided for the purpose, or throwing away or disposing of any burning article or any combustion product is prohibited.
- 10. Putting up camping tents in areas other than those ifficially designated for camping is prohibited.
- 11. Thowing away trash or any other litter anywhere other than is waste cans or bins for that purpose is prohibited.
- 12. Sound reproduction devices turned up to an unreasonable volume that is deafening to the general public and affects the habitat of the flora and fauna is prohibited.
- 13. Megaphones or other devices for making commercial, religious, or political announcement are prohibited.
- 14. Hanging hammocks from trees within the visiting areas is prohibited.
- 15. Hanging tarpaulins or any other sun or rain protection from trees is prohibited.
- 16. No sales of any kind are permitted.
- 17. Chasing, killing, capturing, bothering, or destroying any species of wildlife that lives in or visits these areas is prohibited.
- 18. Bringing any kind of domestic or wild animal into the visiting areas, except for guide dogs accompanying blind people is prohibited. And letting animals loose or leaving them in these areas is also prohibited.
- 19. Extracting material from the earth's crust of any other natural resource from the recreational areas is prohibited.
- 20. Basketball, baseball, tennis, volleyball, and other games of the kind are prohibited. Only passive recreation activities are allowed.
- 21. The use of bicycles, skates, motorcycles, skateboards, horses, etc. is prohibited outside the areas specially designated for such purposes or without written authorization from the Department of Natural and Environmental Resources.
- 22. Possession, bearing, or use of blades or knives of other such instruments, other than those commonly used for cooking, are prohibited in the recreational areas.
- 23. Explosives, fireworks, firecrackers or other pyrotechnic devides, except for flares in case of emergency, are prohibited.
- 24. Fishing or the use of fishing gear is prohibited except in the areas authorized and duly identified for such purposes.
- 25. Use, possession, distribution or possession with the intent to distribute narcoties in the camping areas or in the surroundings forest is prohibited.
- 26. Use of alcoholic's beverages in the recreational areas is prohibited.
- 27. Use of natural areas or places other than those designed for toilet needs is prohibited.
- 28. Washing cars in bodies of water is prohibited.
- 29. Use of power generators, except for activities previously authorized by the Department of Natural and Environmental Resources, is prohibited.
